- 2) PERLANTIKAN ETIQA FAMILY TAKAFUL BERHAD SEBAGAI PENANGGUNG TAKAFUL SKIM KPDRM BAGI TEMPOH 1/3/2018 – 28/2/2019**

1. LATARBELAKANG

1.1 Mesyuarat Anggota Lembaga KPDRM yang bersidang pada 26hb. Februari 2018 telah memutuskan untuk melantik **Etiqa Family Takaful Berhad** (“Etiqa Takaful”) sebagai penanggung takaful bagi skim insurans / takaful berkelompok KPDRM dan skim KOP Perubatan bagi tempoh **1/3/2018 hingga 28/2/2019** berikutan penarikan diri oleh Sterling Insurance Brokers Sdn Bhd. KPDRM akan bertindak sebagai wakil korporat kepada Etiqa Takaful dan akan mengurus tadbir sendiri skim-skim insurans / takaful KPDRM.

1.2 Perlantikan Etiqa Takaful walau bagaimanapun tidak melibatkan sebarang perubahan dari segi nilai manfaat serta kadar premium yang berkuatkuasa sebelum ini. (*Nota : Bagi KOP Perubatan, kadar premium adalah sama sebagaimana pekeliling KPDRM bertarikh 1hb. September 2017 dan 1hb. Februari 2018*).

2. TUJUAN

2.1 Pekeliling ini bertujuan untuk memaklumkan semua anggota KPDRM berhubung :-

- 2.1.1 Penamatan kontrak perkhidmatan Sterling Brokers sebagai pengurus tadbir skim serta syarikat-syarikat penanggung insurans yang mereka lantik, berkuatkuasa pada 28/2/2018.
- 2.1.2 Perlantikan Etiqa Takaful sebagai penanggung takaful bagi skim-skim KPDRM berkuatkuasa mulai 1/3/2018 – 28/2/2019.
- 2.1.3 Mengelakkan Asia Assistance Network Sdn Bhd (“AAN”) sebagai Pentadbir Pihak Ketiga (TPA) bagi menguruskan kemasukan wad bagi Skim KOP Perubatan.
- 2.1.4 Peringatan tarikh akhir mengemukakan tuntutan bagi tempoh polisi 1/3/2017-28/2/2018.

3. SKIM TAKAFUL BERKELOMPOK MANFAAT KEMATIAN DAN KEMALANGAN (GTL) BAGI TEMPOH 1/3/2018 – 28/2/2019.

3.1 Lanjutan dari penarikan diri Sterling Brokers, KPDRM telah mengambil langkah meminimumkan impak isu peralihan dengan mengekalkan Etiqa Takaful sebagai penanggung Skim Insurans Kelompok KPDRM.

3.2 Kadar premium dan manfaat skim kekal sebagaimana sebelumnya.

4. SKIM TAKAFUL BERKELOMPOK MANFAAT PENGHOSPITALAN DAN PEMBEDAHAN (GHS) BAGI TEMPOH 1/3/2018 – 28/2/2019.

4.1 Bagi skim GHS atau dipanggil Skim KOP Perubatan, KPDRM turut melantik Etiqa Takaful sebagai penanggung insurans mengantikan MPI Generali Berhad.

4.2 KPDRM walau bagaimanapun mengekalkan Asia Assistance Network (M) Sdn Bhd (AAN) sebagai pentadbir pihak ketiga (TPA) yang akan menguruskan pengeluaran surat jaminan dan kemasukkan ke hospital bagi peserta-peserta skim. Langkah ini juga bertujuan mengurangkan impak isu peralihan penanggung insurans lanjutan dari penarikan diri oleh Sterling Brokers.

4.3 Sehubungan dengan itu, proses kemasukkan ke hospital kekal sebagaimana tempoh terdahulu. Bagi tujuan kemasukkan hospital, peserta skim boleh memaklumkan kaunter kemasukkan wad hospital bahawa :-
